Anne gave an update on the faculty meeting and various actions that took place there.

Middle states is a serious process, and we are going into a review not in the best shape. This is unfortunate because many people have worked hard to prepare. When faculty are not willing to comply with Middle States, such as the items outlined by Jennifer Jensen, we are not putting ourselves in a good light for review. This includes the fact that the faculty refuses to have compliance with Middle States in R&P. If we are not accredited, we will not be eligible for federal funding.

People at the faculty meeting felt that it shouldn't have to be in R&P. That is the same as giving the accrediting body the right to tell us how to do things.

Anne and Jennifer are going to discuss it further.

Faculty teaching Close Relatives

Reviewed Guidelines on Faculty Instruction of Children and Close Relatives, which will go into R&P. The committee discussed language and made some changes. Anne will send out the final language and Ed Pol will vote at the next meeting.

 - 3.10.1 Scholastic Probation

Revision of the probation policy was discussed. The current probation penalizes students who bring in transfer credits.

Are the GPA cut-offs for reinstatement appropriate? The faculty reviewed the gpa policy at other universities to ascertain whether we should use a similar figure.

The committee agreed to use a 2.0 gpa threshold for probation in all grade levels.

o 3.7.3.2 Make-up Exams

Revision of the makeup exam policy was discussed. Does this take away from a faculty member's prerogative to allow a makeup final exam in case of a student being unable to take an exam due to a legitimate reason? No, but the student should still submit a petition for a makeup exam so that it's official.

Committee voted in favor of taking this change to Faculty Steering Committee for a first reading at the faculty meeting.
